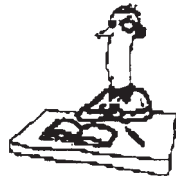

活動報導

● 40週年年會

本會6月6日晚間在珍寶海鮮城隆重舉辦「40週年慶祝晚會」，現場匯聚台美主流政府官員、國會議員、商界領袖、歷任榮譽會長及會員逾420人同慶。整場晚會旨在回顧商會40年來的輝煌歷程，並以「組團隊、進主流、建平台、衝經濟、創共贏」的精神，攜手邁向下一個精彩的四十年。

當晚貴賓雲集，包含駐休經文處副處長陳育仁、科技組組長陳品詮、僑教中心主任王盈蓉；美方政要則有國會議員Al Green、福遍縣代理縣長黃安祥（Daniel Wong）、糖城市長Carol McCutcheon、斯坦福市議員譚秋晴（Alice

Chen），以及哈里斯縣第四區區長Lesley Briones的幕僚長李成純如（Alice Lee）等各界僑領，共同見證商會成立40年來對大休斯頓地區的卓越貢獻。

晚會由主持人古玉枝、李恆依聯袂主持，並在聲樂家陳兆香領唱美國與中華民國國歌中拉開序幕。

現任會長李雄在主席致詞中介紹了台商會的背景與歷史定位。他指出，台商會成立40年來，始終扮演連結台灣商界與北美多元社群的重要橋梁，並已成功建立德州最大的台灣商業社群。他特別感念創會會長楊朝諄，當年更進一步創辦了北美洲台灣商會聯合總會，影響深遠。如今，休士頓台商會已是全球組織的重要成員，聯合了超過68個國家的跨國企業協會，成員在全球科技和製造業供應鏈中佔有舉足輕重的地位。

晚會的重要高潮之一為頒發多項重量級獎項，表彰對商會及社區有巨大貢獻的個人與企業：

▲ 終身成就獎：頒發給商會從無到有的奠基者、終身顧問周政賢。

▲ 全球台商卓越領袖獎：頒發給長期大力支持商會的金城銀行董事長吳光宜。

晚會最溫馨的時刻，則是頒發「鸚鵡情深獎」給結婚滿60周年的鑽石婚夫婦魏主成與魏林喜美。兩位長輩原本已計劃於2024年落葉歸根返台定居，此次特別攜手從台灣飛回休斯頓接受這份榮譽，贏得全場熱烈掌聲。

在會務交接與展望部分，李雄會長現場介紹了新任理事團隊（含現任）：何真、郭宗岳、楊禮維、辜千慈、鄭鵬宇、張碩仁、張世勳、張園立、林翠梅、古玉枝。李雄強調，本會未來將

持續聚集年輕一代、推動全球商業合作，並秉持「沒有最好，只有更好」的精神讓商會發揚光大。

在娛樂節目方面，首先由「東風樂團」帶來《你是我的小蘋果》、《東風夜華》等精采室內合奏。隨後，特別邀請自台灣的「保底女王／台灣濱崎步」王彩樺登台演出。國會議員Al Green更親自代表美國國會頒發「特別國會榮譽證書」（Congressional Certificate of Honor）給首次來到德州演出的王彩樺，並強調將持續支持台灣、確保台灣和平。

王彩樺隨後在FASCA（海外青年文化志工）學員頂著沉重「三太子」的伴舞下，熱鬧獻唱招牌金曲《保底》，台下貴賓互動瘋狂、歡樂滿場。晚會最後在全體團隊與歌手大合唱《愛拚才會贏》的歌聲中畫下圓滿句點。而當晚壓軸的幸運大獎——長榮航空「休斯頓往返台北」來回機票，最終由幸運兒張瓊勻抽中。

II. President's Report

This was the first Board of Directors and organizational planning meeting of the 40th term. During the meeting, the leadership team and the responsibilities of each committee—including the Secretariat, Finance Committee, Information and Communications Committee, Events Committee, and Public Relations Committee—were formally established.

The Board also planned the major activities for the second half of the year, including the September 12 Job Fair, the TCCNA Year-End Meeting in November, a Topgolf networking event, and the reception of visiting delegations from Taiwan.

The Board reviewed the execution of the 40th Anniversary Annual Meeting, the FIFA Watch Party, and the Liberty Festival to identify areas for improvement in future events.

III. Election of Officers and Assignment of Responsibilities for the 40th Term

●Secretariat: Christi Yao will serve as Secretary -General and oversee administrative and organizational affairs. Amy Kuo will serve as Deputy Secretary-General, and Yuming Lin will serve as Executive Secretary. Sam Chang will serve as Vice President and provide additional support.

●Finance Committee:

Peng-Yu Cheng will oversee financial affairs. Yuming Lin will complete the transition with the newly appointed Treasurer. The Annual Meeting generated a surplus, and outstanding sponsorship payments will continue to be followed up. Sand Ku and Sam Chang will assist the committee.

●Information and Communications Committee: Ivan Chang will lead the committee, with assistance from Marv Kuo. The Chamber will standardize the use of the tcchouston.org domain and the info@tcchouston.org email address and establish a formal account transition and access-management system.

●Membership Committee: Marv Kuo will serve as Committee Chair, with assistance from Sam Chang and Sand Ku.

●Public Relations Committee: Christi Yao will lead the committee, with assistance from President

- June 20 – FIFA Watch Party:

The event was lively and well attended, and the decorations were thoughtfully prepared. Special thanks were extended to Mae for arranging the food order.

- June 28 – Liberty Festival:

Many directors and members of the Chamber participated in the event.

2. Planning for Upcoming Activities

Upcoming events include:

- July 11 – Junior Chamber Annual Meeting

- July 16 – Southwest District Breakfast Meeting; the Chamber will need to set up an informational booth.

- July 19 – Hotel and Lodging Association Annual Meeting

- October 10 – Double Ten National Day Flag-Raising Ceremony

- Topgolf Event:

Johnny Tsai will be responsible for coordinating the event. The Events Committee will work with Johnny, with a goal of approximately 50 participants. The event is tentatively planned for July or late August.

- September 12 Job Fair:

The goal is to recruit 80 exhibitors and attract 1,500 job seekers. A planning meeting will be held via Zoom every Thursday at 7:30 p.m. The committee will actively promote the event and recruit participating employers and organizations.

- TCCNA Meeting:

The meeting will be held in Nashville from

November 19 through November 22. Four new directors from the Chamber will join this year, and all directors and members are encouraged to participate actively.

The Board discussed and confirmed the recommended representatives of the Chamber to the Taiwanese Chambers of Commerce of North America. The four directors are Amy Ku, Mae Kuo, Yumming Lin, and Elaine Tao.

- Business Exchanges:

In September, the President will participate in a business delegation to Seoul, South Korea. In late September, the Chamber will receive visiting delegations from Taiwan representing the medical, food and beverage, and biotechnology industries. In November, the Chamber will host a finance and investment delegation. Additional information will be shared and discussed with the Board as it becomes available.

- October 2–5 TCCNA U.S.-Canada Investment Expo in Taiwan:

The Chamber decided that it will not participate in this event at this time.

- Administration and Information Technology:

The Board discussed the feasibility of using Square for credit card payments and establishing a formal system for transferring account credentials and passwords.

- ▲ Complete the detailed budget proposal for the \$5,000 Southwest District grant by July 11.

- ▲ Confirm the Job Fair venue and finalize the promotional materials.

VI. New Business

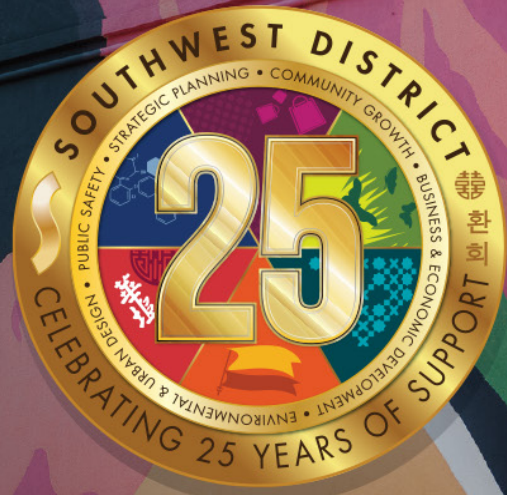
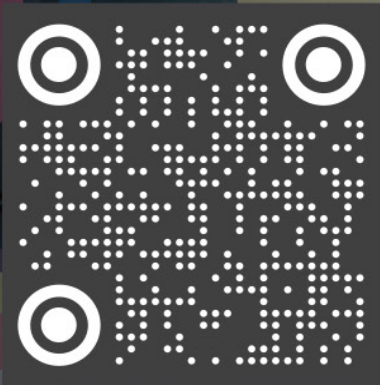
