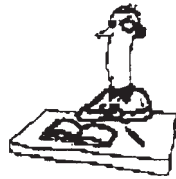

一、通過上次會議紀錄

二、會長報告

會長表示，第40屆理事會各項工作已陸續展開，近期重點包括2026 Greater Houston Career Fair、商會行政制度優化、財務數位化、會員服務及系列講座規劃等。

會長勉勵各委員會持續落實工作分工，加強跨組合作，提升商會行政效率與會員服務品質，同時積極拓展企業合作與青年參與，打造更具影響力的商業交流平台。

三、各組工作報告

● 財務組

(1) 決議導入 QuickBooks Online 建立標準化會計制度，提升財務管理效率與資料雲端化。

(2) 已採購財務專用筆記型電腦，以支援日常會計作業。

(3) 持續追蹤西南管理區補助款、年度企業贊助及其他應收款項。

(4) 討論會員年費比例收費(Proration)制度，鼓勵新會員加入。

● 資訊／通訊組

(1) 建立 president@tcchouston.org 及 accounting@tcchouston.org 官方電子郵件帳號。

(2) 完成新會員歡迎信自動寄送系統，以會長的名義，以示慎重。並考慮加入歡迎禮包 (welcome package)。持續建置商會 LinkedIn 平台及官方數位形象。

● 法務組

法務組由 Jackson 擔任組長。啟動商會章程 (Bylaws) 修訂作業，討論會計年度調整及理事席次等議題。

● 會員組

(1) 歡迎新會員 Albert Yang, Dinkle Coropration, USA.

(2) 持續更新會員資料，完善新會員通知及服務流程。

● 活動組

持續規劃下半年各項活動，包括：

(1) 中小企業 Success Series 英文講座，已規劃至2026年10月，每月一主題，涵蓋資金籌措、AI應用、行銷策略、招募留才、資安防護等。積極尋求銀行（如BOA、中信）贊助場地與經費，並設計收費機制（會員免費，非會員收費）。

(2) Retirement Wellness 系列講座：服務年長會員，主題包含遺囑信託、再婚文件準備、跨境資產稅務規劃等。此提案已獲通過。

(3) Topgolf 會員聯誼、傳統烤肉活動、與台灣青年商會合作辦理交流活動。

四、討論事項

● 2026 Greater Houston Career Fair

理事會持續討論9月12日就業博覽會籌備工作。

(1) 持續與 Houston Christian University (HCU) 等學校洽談合作。

(2) 積極邀請企業、醫療機構及政府單位參與。

(3) 加強招商及企業贊助。討論邀請 Panda Express 等餐飲品牌贊助

(4) 規劃中英文新聞發布會及雙語宣傳，提高活動曝光度。將印製中英雙語傳單，於餐館、超市、教會等地張貼。規劃於8月8日（中文場）及8月18日（英文場）舉辦新聞發布會進行宣傳。

● 近期活動

近期將陸續參與及辦理：

(1) 青商會聯誼活動：青商會8月8日聯合聯誼活動（Houston）尋求贊助：理事會並通過贊助台灣青年商會聯誼活動，以持續深化雙方合作關係。會長主恩向理事會提案，爭取臺商會贊助\$500以支持活動。經由理事會投票通過這次的贊助，副會長SAM將參加8/9的青商會理事會。

(2) 國慶晚宴：決定包一桌國慶晚宴，費用為\$1000，採會員自付\$50、本會補助一半的模式。

• 十鼓文化活動：協助銷售9月25日的活動票券（\$100 VIP票與\$35普通票），剩餘票券將在理事會推廣。

• 盧易之音樂會：已成功向一個醫療旅行團售出30張票

● 商務交流與訪團接待

理事會討論9月份多項商務交流計畫，包括：

• 接待台灣醫療代表團，生技及健康產業訪團，協助企業商機媒合，規劃企業交流晚宴，持續與國內外商業團體建立合作關係。

Business Discussion & Announcement

I. Approval of Previous Meeting Minutes

The minutes of the previous meeting were approved as presented.

II. President's Report

The President reported that the various initiatives of the 40th Board of Directors are now underway. Current priorities include the 2026 Greater Houston Career Fair, improvements to the Chamber's administrative systems, financial digitalization, membership services, & the planning of educational seminar series.

The President encouraged all committees to continue carrying out their assigned responsibilities, strengthen cross-committee collaboration, improve administrative efficiency and the quality of membership services, and actively expand business partnerships and youth participation in order to build a more influential business networking platform.

III. Committee Reports

(1) Finance Committee

- The Board approved the implementation of QuickBooks Online to establish a standardized accounting system, improve financial management efficiency, and maintain financial records in the cloud.

- A laptop dedicated to financial and accounting work has been purchased.

- The committee will continue following up on grants from the Southwest Management District, annual corporate sponsorships, and other outstanding receivables.

- The Board discussed a prorated membership fee system to encourage new members to join during the second half of the fiscal year.

(2) Information and Communications Committee

- Official email accounts, including president@tcchouston.org and accounting@tcchouston.org, have been established.

- An automated welcome email system for new members has been completed. The welcome messages will be sent in the President's name to provide a more formal welcome.

- The Chamber is also considering offering a welcome package to new members.

- Development of the Chamber's LinkedIn platform and official digital presence will continue.

(3) Legal Committee

- Jackson will serve as Chair of the Legal Committee.

- The committee has begun revising the Chamber's Bylaws, including discussions regarding the fiscal year and the number of Board seats.

(4) Membership Committee

- The Chamber welcomed new member Albert Yang of Dinkle Corporation USA, telephone number 832-391-8231.

- The committee will continue updating membership records and improving the new-member notification and service process.

(5) Events Committee

The committee will continue planning activities for the second half of the year, including:

- The Small Business Success Series, an English-language seminar series planned through October 2026. Monthly topics will include access to capital, artificial intelligence applications, marketing strategies, employee recruitment and retention, and cybersecurity. The Chamber will seek sponsorships from banks such as Bank of America and CTBC Bank to support venues and program expenses. Members will attend free of charge, while non-members may be charged a registration fee.

- The Retirement Wellness Series, serving senior members with topics such as wills and trusts, legal document preparation for remarriage, and cross-border estate and tax planning. The proposal was approved.

- A Topgolf networking event, the Chamber's traditional barbecue event, and joint networking activities with the Taiwanese Junior Chamber of Commerce.

IV. Discussion Items

(1) 2026 Greater Houston Career Fair

The Board continued discussing preparations for the September 12 Career Fair.

- Continue exploring partnerships with Houston Christian University and other educational institutions.

- Actively invite businesses, healthcare organizations, and government agencies to participate.

- Strengthen employer recruitment and corporate sponsorship efforts, including discussions about inviting restaurant brands such as Panda Express to become sponsors.

- Organize Chinese- and English-language press conferences and produce bilingual promotional materials to increase public awareness.

- Bilingual flyers will be distributed at restaurants, supermarkets, churches, and other community locations.

- Press conferences are planned for August 8 in Chinese and August 18 in English.

(2) Upcoming Activities

Upcoming activities include:

- Taiwanese Junior Chamber Networking

Event: The Taiwanese Junior Chamber requested sponsorship for its joint networking event in Houston on August 8. The Board approved a \$500 sponsorship to support the event and strengthen cooperation between the two organizations. Vice President Sam Chang will attend the Junior Chamber's Board meeting on August 9.

- Double Ten National Day Banquet: The Chamber decided to reserve one table at a cost of \$1,000. Each participating member will pay \$50, with the Chamber subsidizing the remaining half of the cost.

- Ten-Drum Cultural Performance: The Chamber will assist with ticket sales for the September 25 performance. VIP tickets are \$100, and general admission tickets are \$35. Remaining tickets will be promoted among Board members.

- Yi-Chih Lu Concert: Thirty tickets have already been sold to a visiting medical tourism delegation.

(3) Business Exchanges and Visiting Delegations

The Board discussed several business exchange programs planned for September, including:

- Hosting a Taiwanese medical delegation.

- Hosting biotechnology and health-industry delegations.

- Assisting with business matchmaking.

- Organizing a business networking dinner.

- Continuing to build relationships with domestic and international business organizations.

V. New Business

The Board recommended continuing to strengthen cooperation with other chambers of commerce, promote youth leadership development and business exchanges, and advance the Chamber's digital management systems.

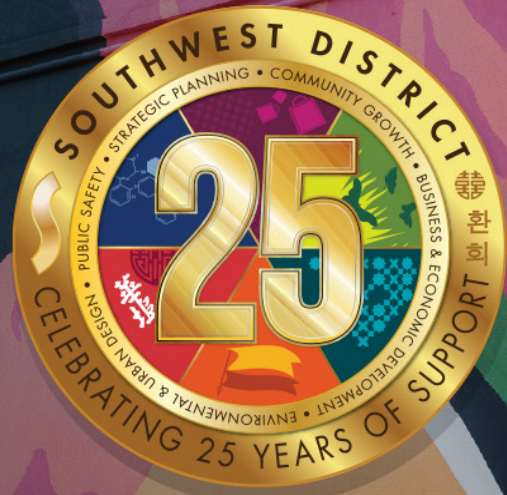
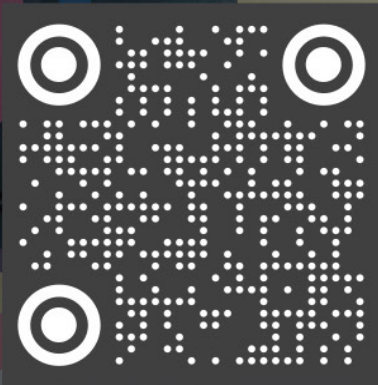
